

TERMS OF USE

The Wakota Federal Credit Union Web Site is available for you dependent upon your acceptance without modification of the terms, conditions, and notices contained herein. Your use of the Wakota Federal Credit Union Web Site establishes your consent to all such terms, conditions, and notices.

Restrictions to Prohibited or Unlawful Use:
